1 POINT	Each prior alcohol-drug-related offense other than DUI except as counted above

3 POINTS	If 5 or more moving violations WITHIN 5 YEARS

Fine amounts include surcharges. Court costs and restitution for appointed counsel may also be added.

Each probation sentence typically will include: Victim impact panel attendance (\$50), substance abuse evaluation within 30 days, follow recommendations of evaluation. Probationers will be subject to random searches and drug screens. Generally, ignition interlock will be ordered for 6 months for any 2nd or greater DUI within 5 years. Other conditions may also be added. All DUI alcohol convictions have special condition of no alcohol possession or consumption during the entire term of probation.
